Waiver and Release of Liability Agreement

I am a participant in the Shelter House Community Shelter & Transition Services (“Shelter House”) **Brake the Cycle of Homelessness Event**. I understand, acknowledge and agree that bicycling activities have inherent risks. I freely and voluntarily assume complete responsibility for all such risks, and for any and all injuries that may occur as a result of those risks or arising out of those risks, even if injuries occur in a manner that is not foreseeable at the time I sign this instrument. I understand, acknowledge and agree that by voluntarily assuming the risks involved, I will be solely responsible for any loss or damage sustained, including personal injuries, damage to property, or death. I understand that participation in this event is conditioned upon execution of this Waiver and Release of Liability. In consideration of permission to participate, I agree to defend, indemnify and hold the Shelter House and all of its departments, trustees, directors, officers, servants, agents and employees harmless from any bodily injury, property damage or other incident whether arising out of my participation or otherwise.

In consideration of permission to participate, I hereby RELEASE, ACQUIT AND COVENANT NOT TO SUE, the Shelter House and any or all of its departments, trustees, directors, officers, servants, agents and employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands and causes of action whatsoever arising out of or related to my participation and any loss, damage, or injury, including death that may be sustained by me, or any property belonging to me, while participating in this event including travel to and from this event. I further agree to indemnify, defend and hold harmless the RELEASEES from and against any claims made or threatened to be made against any RELEASEE arising out of my participation in this event including reasonable attorney’s fees and costs.

It is my express intent that this Waiver and Release of Liability shall bind me, the members of my family and spouse, if I am alive, and my heirs, beneficiaries, successors, assigns and personal representative if I am deceased. I hereby further state that I UNDERSTAND THIS WAIVER AND RELEASE OF LIABILITY AND SIGN IT VOLUNTARILY.

If the undersigned is executing this Waiver and Release of Liability in a representative capacity (on behalf of an individual under the age of 18 years, for example), then the undersigned represents that the undersigned has the authority to execute this instrument on behalf of the above named participant, and bind him or her hereto, and the undersigned agrees to indemnify, defend and hold harmless the RELEASEES against any claims for damages by or on behalf of the above named participant and make good and save harmless the RELEASEES from any loss, damage or cost (including but not limited to reasonable attorney’s fees) that the RELEASEES might incur or be required to pay if any litigation is brought by or on behalf of the above named participant.
